OVERVIEW: The Doctoral School in the Humanities was born from the union of three pre-existing doctoral courses of the University of Trieste, each of whom with a long and peculiar tradition: the doctorate in Italian literature and philology, the doctorate in "Forms of historical knowledge from the Middle Ages to the contemporary age" and the doctorate in Ancient Studies. At present it is based at the Department of History and Cultures from the Antiquity to the contemporary age (=DISCAM). The School - the details of whose organization and scientific purposes are illustrated by its website - is structured in three curricula ("indirizzi"), each corresponding to the previous doctorates and on a modular plan, capable of incorporating more courses of humanistic content. It is governed by a Director, a Scientific Board and the College of Professors. Its main objective is to work on the basis of the disciplinary and methodological autonomy of each component, under the supervision of the Scientific Board, and to develop as much as possible the interdisciplinary perspectives and approaches between literary, historical, archeological, art-historical and ancient classic studies, with significant openings towards the juridical, philosophical and political science studies. Each course, under the guide of its College of Professors, works autonomously as far as the recruiting procedures, didactics, periodic evaluations and final examinations procedures are concerned. At the same time, each course cooperates yearly to a common program consisting of monthly scientific meetings on a general topic to be dealt with on an interdisciplinary basis. More activities aim to give the students the necessary knowledge and competences in order to move autonomously on the level of international research. The students are recruited with distinct examinations for each course and are requested to participate regularly to the activities decided by the College of Professors of the course and of the School. The Professors of the School ensure constant supervision to the students' research work for the final thesis; and the School supports the latter, in cooperation with the DISCAM, in order to guarantee the students structures and resources necessary for achieving its institutional aims. The School assists its students in developing their national and international relationships; it favors the publication of their studies and offers support and counseling in view of postdoctoral research or working activities. Candidates will prove a very good knowledge of spoken and written French (or Italian, in the case of candidates not Italian citizens). The required level of competence, preferably certified UNIcert III (European Level C1) will correspond at least to the level C1 according to CEFR (Common European Framework of Reference for Languages), and defined as follows: "Effective Operational Proficiency or upper intermediate. Can understand a wide range of demanding, longer texts, and recognise implicit meaning. Can express him/herself fluently and spontaneously without much obvious searching for expressions. Can use language flexibly and effectively for social, academic and professional purposes. Can produce clear, well-structured, detailed text on complex subjects, showing controlled use of organisational patterns, connectors and cohesive devices".

developments (a comparative inquiry between Trieste and Bordeaux)" aims to start researches on forms of social co-existence defined by the category of "cosmopolitism". Cosmopolitism is here meant as a subject of study not so much in its aspect of intellectual product of a philosophical and political, literary, religious or juridical culture with a universalist, humanist, rational or irenic inspiration, as rather a series of social behaviours of respect, tolerance, resulting from the cultural sociability produced by urban commercial civilizations. In this perspective we suggest the relevance of a comparative analysis of the Trieste and Bordeaux seaports, their respective historical, geographical and territorial specificities and socio-economic and cultural differences notwithstanding. Pre-conditions, manifestations and evolution of cosmopolitanism will be analysed at the level of social history, family history, history of mentalities in their relationships with the institutional and administrative institutions and procedures, taking into particular account a gender approach.
